## ABOUT

The **Leisure Involvement for Everyone (L.I.F.E.) Program** assists individuals and families living with low income to access recreation services and programs. SEAPARC Recreation and its regional partners are committed to ensuring residents have access to a variety of leisure opportunities.

## BENEFITS

**Approved Applicants** will receive the following:

- Membership Pass: Valid for 2 years from the approval date
- Unlimited Free Drop-in Sessions at SEAPARC Recreation Centre
  - OR 50% off a 1-year Regional Recreation Pass
- 52 additional Drop-in Visits to Regional Partner Centres annually (see all municipal partners below)
- Subsidy credit toward registered programming
  - Subsidy credit can be used for program registration at SEAPARC Recreation, up to a maximum of \$50 per program.
  - Value of \$250 per child and \$150 per adult, valid for 2 years.

## ELIGIBILITY REQUIREMENTS

1. Only resident with Sooke, East Sooke, Otter Point and Jordan River may apply for this program. This includes all household members/dependents residing at the same address.
2. Applicants must be able to demonstrate proof of residency.
3. Combined household income must be at or below the following levels to qualify:

*\*Numbers are determined by the Statistics Canada lo-income threshold, including inflation changes in the regional cost of living allowance.*

## HOW TO APPLY

1. **Complete one application** per family/household
2. **Gather proof of residency** for each adult applicant, such as a utility bill, rental agreement or government ID.
3. **Gather proof of income** for each adult, most recent Notice of Assessment. To obtain a copy of your NOA call Revenue Canada at 1-800-959-8281 or visit <http://www.cra-arc.gc.ca/myaccount>
4. Bring all required documents into SEAPARC Recreation Centre or send all required documents to [seaparc@crd.bc.ca](mailto:seaparc@crd.bc.ca)

**Your application will be reviewed, and you will be notified within 2 weeks of the date received of approval or not.**

## GUIDELINES

- All information provided in the application remains confidential, unless required by a Freedom of Information request.
- Subsidy credit cannot be used for single admissions or merchandise.
- LIFE cards are non-transferable, and are not eligible for cash or credit
- Participants must have their picture taken for their LIFE card
- \$5 + tax replacement charge for lost cards
